South Texas Waterways Advisory Committee Meeting Minutes 13:30, 20 April 2023 Meeting was held at the Ortiz Center

A. Call to order/opening remarks by chairman

At 1333 Vice-Chairperson of STWAC, Ms. Brandi Rogers. called the meeting to order. A quorum was reached.

B. Administration

The January 19, 2023 meeting minutes were approved.

C. Coast Guard Remarks

CAPT Jason Gunning, U.S. Coast Guard Sector Corpus Christi, provided remarks thanking all for coordination with dredge activities. He also highlighted importance of updated Sexual Assault and Sexual Harassment reporting requirements and announced completion of the gangway accident Report of Investigation.

D. Presentations

- 1. Bollard Integrity Ms. Marisa Alaniz
 - Ms. Alaniz, PCCA Operations Engineer, shared test methods and completed work to test bollard strength at Port of Corpus Christi docks. To date, Docks 8, 9, 14, 15, and the Avery Docks have undergone nondestructive test. The Port has identified and plans to make repairs to identified bollards.

2. POCCA Engineering Updates

 LCDR Lauren Garofalo, US Coast Guard, presented new policy regarding reporting sexual misconduct on US vessels. 3. Ship Channel Improvement/Pipeline Removal update

 Ms. Laura Kinder, Port of Corpus Christi, shared updates for the improvement project. 5 AEP lines are to be removed starting Jun 2023, Avery Point line removal is scheduled for May 31-Dec 2023, 3 lines at the Bulk Terminal is scheduled for May-Aug 2023, and Viola Turning Basin lines are schedule for May-Aug 2023

4. US Coast Guard 2018 Gangway Marine Casualty brief

• LCDR Lauren Garofalo, US Coast Guard, provided a presentation on the Gangway Casualty Findings. A list of causal factors related to the incident were presented in detailed and included: Lack of adequate Safety Management System guidance, poor decision making by the vessel's crew to take apart gangway prior to all personnel boarding the vessel, the inadequate or non-existing lashings to secure the gangway, the removal of the gangway safety netting under the gangway, the less than ideal securing location for the gangway on the hose rail due to facility layout, size of the gangway lips compared to the size of the hose rail on the vessel, a lack of US law pertaining to gangway securing requirements, a lack of US laws requiring regulated facilities to have a means of recovering a person from the water, and a lack of US law requiring regulated facilities to have training to recover a person from the water.
